Any exposure to currencies other than US dollar will be hedged back to US dollars.

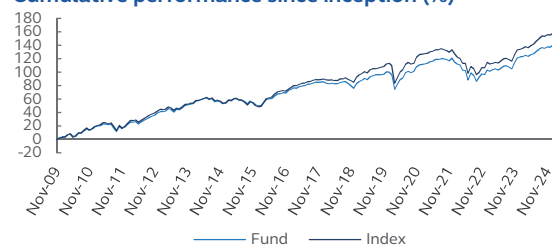
