# Investment objective

The Fund's primary objective is to seek to achieve a high rate of return relative to typical high yield investments by investing primarily in a portfolio of short-term, lower volatility, high vield debt with an average duration of approximately 12-24 months. The Fund will invest in a diversified portfolio of typically below investment grade high yield securities, including global corporate bonds, bank debt, convertible bonds, commercial paper and preferred stocks.
